From the Manager

The 2022-2023 financial year saw our previous manager Graham hang up his hat after almost 10 years in the manager's role of HFQ and left me with some very large shoes to fill. With the easing of covid restrictions, we were able to be more present in the hospitals as well as community and hosted many events for our members.



This year the Board has gone through significant change with some members moving on and others joining for the first time. This has allowed us to expand our resource and knowledge base through the board member's lived experiences and education in varying areas. The members who served on the board during the 2022-23 financial year are as follows; David Stephenson, Leanne Stephenson, Jodie Caris, Adam Lish, Robert Weatherall, Tony Ciottariello, Shannon Wandmaker, Charles Eddy, Shannon Gracey, Belinda Waddell, Leah Emery and Chris Fullelove. I would like to thank all board members for their contributions throughout the year.

I commenced as Manager in October 2022 right in the heart of Bleeding Disorders Awareness Month and Samantha Williams has continued on as Administration Officer, both in a part time capacity. We have also utilised the help of a few external suppliers. Thank you to Gigi Lacey (HR & policy advice), Sunita Phillips (Accountant) and Kristie White & Don Crombie (Auditors).

The foundation is very fortunate to have received the generous support of volunteers across Queensland and we rely heavily on these wonderful people giving up their spare time to help in the delivery of our support services. Volunteers have assisted with serving on the board, fundraising, administration and office assistance, and running of events.



Particular thanks goes to Tony Ciottariello who donates one day a week to assist in the office and running events. We also thank our youth leaders, Adam Lish, James Rogers, Craig Bardsley, Darian McCrindle and Lean Metzroth for their support with youth events. We cannot thank our board and volunteers enough for the supportive role they play in the successful operation of HFQ.



HFQ also maintains a very close working relationship with the RBWH & QCH Haemophilia Centres and are grateful for their ongoing support of HFQ and our events throughout the year.

Community

HFQ continues to evolve as the only patient support and advocacy organisation supporting people affected by bleeding disorders in Queensland. We serve all persons affected by bleeding disorders in Queensland, not just those with haemophilia and all are welcomed by us including, but not limited to, von Willebrand Disease, platelet function disorders and rare factor deficiencies. We work with individuals, groups and the Haemophilia Treatment Centres to understand and meet the needs of people affected by bleeding disorders and how best to support, empower and connect them to each other and to the services available to them.

During 2022-23 we published our quarterly magazine 'the H Factor' and distributed resources and information of interest to members from our national body, Haemophilia Foundation Australia (HFA) and other sources. This years updates included posts and resources on World Haemophilia Day, World Hepatitis Day, World Aids Day and our first ever month long Bleeding Disorders Awareness Month.

We have implemented more environmentally friendly alternatives to delivering this information where possible, including electronic mail outs of the H Factor, text message blasts for events and social media postings, to reduce our environmental impact wherever possible.

Education and Support

HFQ remains committed to sourcing and understanding current research and clinical practice for people with inherited bleeding disorders. We maintained our subscription to WFH Haemophilia Journal, and we have a small resource library available for members to access on request.

HFQ continued to provide peer based social and emotional support for members throughout the year. These were provided on both a one-on-one basis, as well as group support events such as our Mens & Women's Groups and regional outreach.



Website and Social Media

The website remains a way to keep members updated on the activities being run. Google analytics shows there was 2,123 users who accessed 2.5 pages on the site, an increase from last year and that 71% were from Australia and, of the known locations, an average of 57% of total traffic was Queensland specific.

Social media, however, is our peak communication tool within the community. The Meta Business Suite analytics advises that our Facebook post reach was 4,235 for the financial year, up 21.4% from the previous year. Instagram remains not as popular but we have seen a significant increase in the last year with a 27.8% increase in post reach. Both Facebook and Instagram profile traffic is up significantly however, with a 344.9% and 143.3% increase respectively in the last year. A huge improvement proving our social media remains an asset in communicating with our members. Key spikes in traffic was noted during Bleeding Disorder Awareness Month and around larger events such as Community Camp and our Summer Function.



Peer Support Services

HFQ continued to run its regular peer support programs throughout the year. The women's events were held quarterly and the men's lunches were held monthly. There was 4 women's events held and all had great attendance with an average of 15 women at each event. There was a few men's lunches cancelled due to low rsvp numbers but there was still 9 held throughout the year at various venues and all had an average of 6-8 in attendance.

We also held a family day in January for our members at Holey Moley Chermide, which included a round of mini golf and a pizza lunch. This was very well attended with 35 people

coming along.

Bleeding Disorders Awareness Month was in its first year of being an entire month long event and HFQ



rose to the occasion with several events on during the month. Notably, we held a memorial plaque unveiling and service to honour those who we have lost from our community.

Youth and Community Camps

The annual youth camp occurred in September 2022 with 12 people in attendance. This is run for children between 12-21 affected by a bleeding disorder. Attendance has been down at youth camps in recent years and will not be going ahead for 2024 until HFQ can run a survey to find what the best option is for the youth portion of our community.

The Community Camp was moved this year to a new venue – Sandstone Point Resort, which was very well received. It sold out in a matter of weeks and had the largest attendance to date with 110 joining us for the weekend at Sandstone Point. We ran a quiz night at the dinner which allowed a panel of experts from the community to speak to the group gathered as well as take questions on challenges faced in a relaxed setting. The camp for 2024 has already sold out with 140 registered so it appears to be a very popular venue.

We have also helped with a Youth Transition Day at the RBWH with a pizza lunch.

Goal 2 of the HFQ Strategic Plan: Engagement and Partnerships

With bleeding disorders being such a rare disease, HFQ has always sort to improve the capacity of individuals and organisations to be advocate for Queenslanders affected by bleeding disorders. We do this through external engagement with other organisations and individuals and through purposeful partnerships.

Most of the engagement at national level is conducted through our peak federal body Haemophilia Foundation Australia (HFA) and HFQ has a board representative that attended meetings in person and via Zoom with other state and territory bodies.

The current representative is our treasurer, Adam Lish and I thank him for his contribution in this.

As in previous years, a close working relationship with the two Queensland Haemophilia Clinics and their staff is crucial to our ability to provide peer support and events for the community, and this is something we have worked on throughout this year. We were able to build a strong working relationship with the psychosocial team at the Queensland Childrens Hospital and would like to thank Lara Nicholson and Tiara Tan for their support in running several events for youth over the last year. I attended several of the QHC staff meetings during the year to remain engaged with the team across both treatment centres. I would





like to thank all of the HTC staff for their support of HFQ functions and awareness campaigns throughout the year.

Goal 3 of the HFQ Strategic Plan: Maximised human element

We have been lucky to have a very engaged board in the last financial year, even with several changes to board member positions during this time. We were also able to welcome new members, who brought with them new skillsets we are able to utilise in their roles on our volunteer board.

To access any additional skills needed, we have also utilised expert external help,

especially in regards to human resources, policy and legislative requirements. The foundation would like to extend it's thanks to our policy consultant, Gigi Lacey who gives her time and expertise to assist HFQ with policy review and strategic planning. I cannot thank our board members, external professional and volunteers enough for their support and dedication in the last year. This is crucial to the successful operation of HFQ.

Goal 4 of the HFQ Strategic Plan: Good governance

As an incorporated association representing people in Queensland living with, or affected by, a bleeding disorder, we follow open, transparent and accountable governance processes. The responsibility for this falls to the staff of HFQ along with the board.

The board assisted in a review of HFQ's constitution along with Gigi Lacey to ensure we are compliant with recent legislative changes for incorporated associations in the not for profit space.

We continue to meet our reporting obligations with Australian Charities and Not for Profit Commission (ACNC), Department of Fair Trading, and Queensland Health, as well as completing an audit of financial year records with an independent auditor.

Donors & Funders

I would like to take this opportunity to extend thanks on behalf of the board and the entire bleeding disorders community, to our generous donors and funders, without whom HFQ would not be able to do half of what they achieve presently.

Queensland Health has continued to support our organisation as our main funder and their ongoing funding and support has enabled us to be maintain financial viability and continue our ongoing projects within the community.

The Prescott Family Foundation have continued their regular annual donation of \$25,000 which allows HFQ to host





the annual camps we organise for youth and community, and without this funding these events absolutely would not be able to go ahead.

The year in review has held many fundraising events organised by members of the community. Special thanks needs to go to Mr Real Estate, Josh Fisher for his golf day fundraiser, Phil Hill of Fitness Compound for his 100 burpee a day for 2023 fundraiser, and the Weatherall family for assisting with a BBQ fundraiser at Rothwell Bunnings and Robyn Holloway for the Toowoomba Bunnings BBQ, both which were huge successes.

Volunteers and Board Members

The board of HFQ is staffed 100% by volunteers who give up their time to help with the successful running of the organisation. The current board membership comprises a mix of experiences and relation to the bleeding disorders community. We always welcome expressions of interest from prospective board members. We also need to thank the volunteers who never hesitate to jump in and help at HFQ events. Special thanks needs to go to Robyn & Mike Holloway and the Weatherall family who have given so generously of their time and energy to HFQ during the last year.

Thanks also needs to go to Graham Norton for his almost decade-long service in the manger's role at HFQ and his ongoing dedication to the bleeding disorders community. I would also like to take a moment to thank the HFQ community for being so welcoming of me as I've stepped into the role as manager. It's been a passion of mine for a long time to be able to serve this community that means so much to me, and to be able to do it as my day job truly is a dream come true. 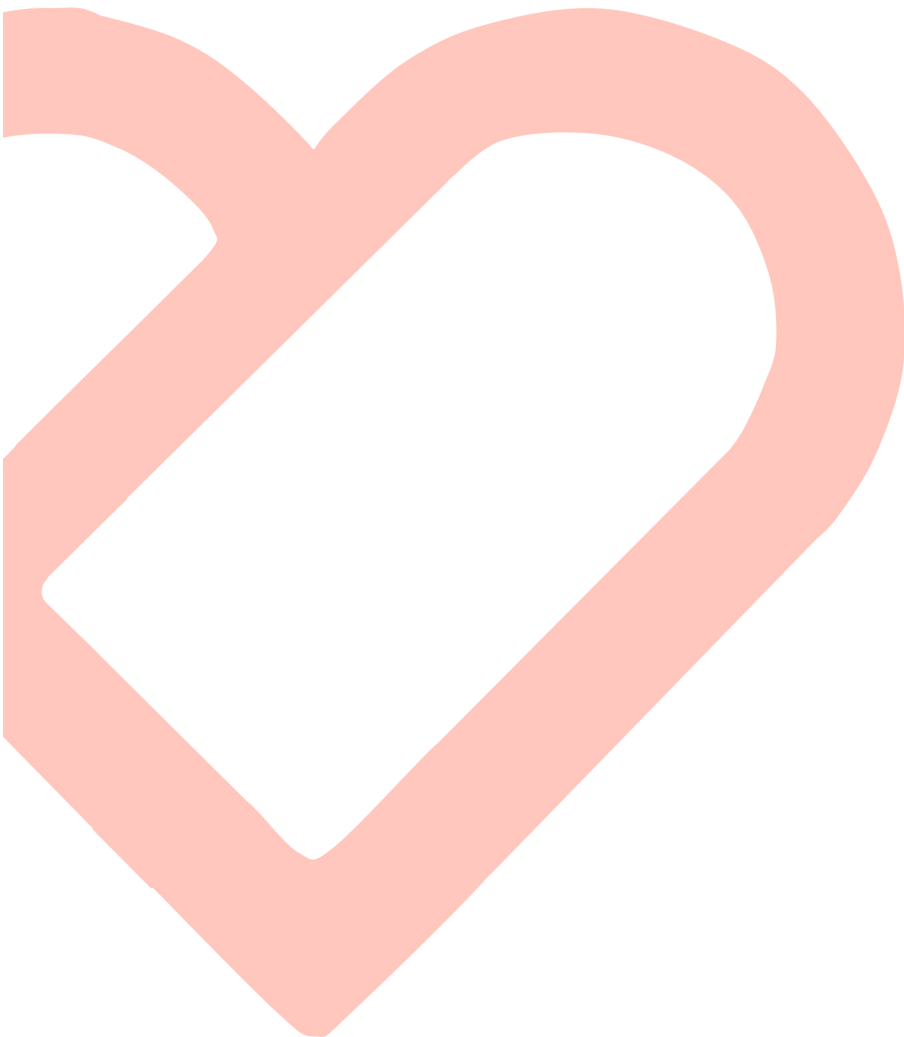

FINANCIAL REPORT

From the Treasurer



My financial report presenting the operating performance and financial position of HFQ as at 30 June 2023 is as follows:

The financial report is a special purpose financial report prepared to satisfy the financial reporting requirements of the Australian Charities and Not-for-profit Commission Act 2012 and the Associations Incorporations Act (Qld) 1982 (as amended by the Associations Incorporation and Other Legislation Amendment Act (Qld) 2017).

The accounting statements have been prepared on an accruals basis and are based on historical cost. HFQ adopts appropriate internal controls and decision-making policies approved by the Board in carrying out activities, programs, duties and responsibilities of HFQ.

Operating Performance

The 2022-23 financial year saw HFQ continue to maintain regular activities and operate within its regular budget.

At this stage, funding from Queensland Health is guaranteed for the current term and is expected to be renewed; Part of HFQ's strategic financial planning is to account for the potential that government funding, at some point in the future, might not be granted to HFQ. This is purely hypothetical, but the Board sees it as a necessary element of long term financial planning to consider all eventualities. It is this reason HFQ intends to grow its wealth, to ensure that the organisation can continue to operate into the future.

Increases in the cash rate has seen modest improvements to HFQ's cash holdings and returns.

HFQ has adopted a low risk approach to investing its funds for the future of the organisation. Fundraising activities are also a key part of HFQ's financial operations.

I would especially like to acknowledge another donation by the Prescott Family Foundation, who have again donated a sum of \$25,000. HFQ would like to thank the Prescott family and we look forward to investing the money into the organisation for the benefit of the community.

I expect HFQ to continue to maintain financial efficiency and incorporate information, such as the increased grants awarded, to better plan for future expenses, be capable of meeting financial obligations, and provide the best services for the bleeding disorders community.

Financial Position

HFQ continues to maintain a stable financial position. The cash at bank balances total of \$328,518.94 and is sufficient for the total financial obligations.

The ongoing support from the Queensland Health grants program enables the Board's objectives and programs to be delivered to the community throughout the year.

In the opinion of the Board the financial reports are in accordance with the Australian Charities and Not-for-Profit Commission Act 2012 including;

- Presenting a true and fair view of HFQ's financial position as at 30 June 2018 and its performance for the year ended on that date;
- Complying with the Associations Incorporations Act (Qld) 1982 (as amended by the Associations Incorporation and Other Legislation Amendment Act (Qld) 2017) and the Australian Charities and Not-for-profit Commission Act 2012;
- At the time of this statement there are reasonable grounds to believe that HFQ will be able to pay its debts as and when they become due and payable.

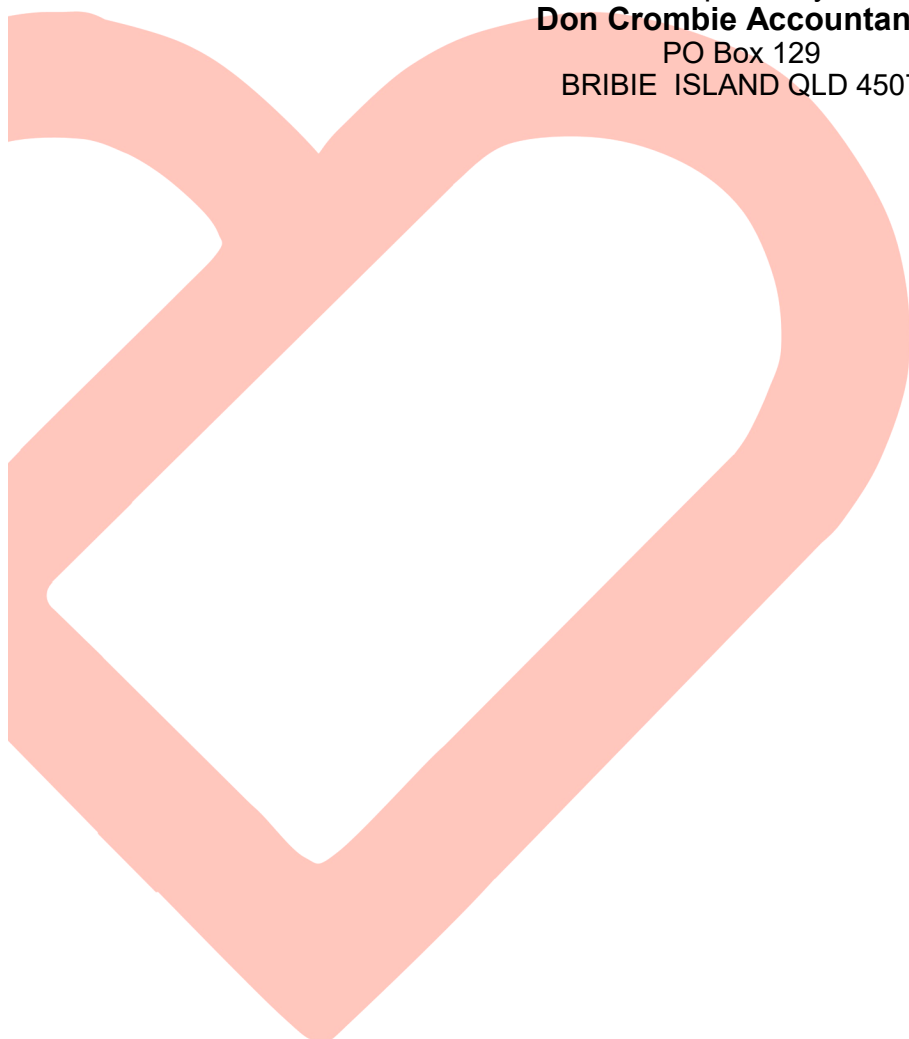
